Lukasz Lisicki – Policy Officer at European Commission DG ENER

A master graduate of the Centre for Europe at the University of Warsaw and Warsaw School of Economics. Participant of the International Visitor Leadership Program (IVLP) in the field of energy security and innovation organised by the US Department of State.

He gained professional experience working as a consultant in the field of regulatory and investment risks and public affairs advisory for the energy companies. He used to work at the EU Agency for the Cooperation of Energy Regulators (ACER) as well as at the Polish Ministry of Energy in the Oil and Gas Department.
